President's Message

Our second monthly meeting on October 11, 2018 was a total success in terms of participation and the technical information exchanged. Fifty members attended the meeting. Do's and Don'ts speaker, David Lindsay, went over the dedicated outside air system and its application in hot and humid environments like ours. Controls round table discussion was superb. The outstanding speakers went over all the aspects of the control system used in HVAC systems. The main emphasis was on how proper implementation of the control system can save energy for the clients. The speakers cautioned the audience not to over-design the control system and make it too complicated, or risk resulting in higher project costs and difficulties in maintenance. The panelists also touched upon cyber security issues and how to prevent unauthorized persons from gaining access to sensitive information through the control system. One of the suggestions was to separate servers that handle control systems from the servers that handle financial or other sensitive information. Speakers expressed that cloud based computing systems and the



internet of things (IoT) will immensely impact future control systems, and we will be able to accomplish tasks that were unthinkable in the past. However, that will further complicate cyber security issues. The main takeaway from the meeting was that our local control experts are willing to help the designer to design a control system that is easy to implement, while achieving all the desired functionalities, thus keep the project costs relatively lower and easier to maintain.

Our next meeting will be on Thursday, November 8, 2018. Mr. Henry Slack, ASHRAE distinguished lecturer, will talk about how can climate change impact indoor air quality and health in the main program. Mr. Slack managed the Indoor Air Program for the U.S. Environmental Protection Agency (EPA), region 4. In that position, he offered quality expertise concerning indoor air to citizens or public agencies with questions on topics as diverse as mold, odors, ozone, carbon monoxide, air cleaners, ventilation systems, and second-hand tobacco smoke. We believe it will be very useful for our members to hear from a society-recognized indoor air quality expert like Mr. Henry Slack.

The November monthly meeting is also declared as a "Membership Promotion Night." ASHRAE is a grassroots organization and members are the most important element of the organization. Therefore, it is incumbent on us to increase our membership and retain our existing members. To that end, our membership promotion committee will go over the importance and benefits of becoming an ASHRAE member. We encourage everyone to bring at least one potential ASHRAE member in the meeting to make our membership promotion night successful.

Technical Session

"Thermostatic Mixing Standards - Best Methods and Relevance to Legionella and ASHRAE Standard 188-2015," by David Lord

This session will focus on best practices and design considerations for distributed and or recirculated hot water systems where stored hot water is tempered to safe temperatures for domestic use. Discussion will include features of various types of thermostatic mixing valves, considerations for the control of legionella in domestic water systems, and implications of ASHRAE standard 188-2015 for the engineering community.

About the Speaker

David Lord, JM Sales Hawaii, Manufacturer's Representative.

David Lord has been a rep in Hawaii since 2003. Formerly with plumbing manufacturers Watts Industries and MIFAB Inc, David took the opportunity to acquire JM Sales when former owner Jack Minaldi retired in 2004. Centered mainly on the commercial plumbing sector, JM Sales represents such manufacturers as Chicago Faucets, Circuit Solver, Leonard Thermostatic Mixing valves and polypropylene pipe manufacturer Aquatherm. David & Susan Lord are the owners and operators of JM Sales.



Main Presentation

"Fixing the Great Indoors: HVAC and Indoor Air Quality" and "How Can Climate Change Impact Indoor Air and Health?" by ASHRAE Distinguished Lecturer Henry Slack

Most of the time, we breathe without a thought, hundreds of times each hour – unless there's a problem. When something's wrong, it's due to pollutants, people, pathways, and pressure differences. The best solution often is to find the sources and control them, or fix the pathways and pressures. This presentation will focus on what goes wrong in our buildings that engineers can manage –intakes, dampers, filters, coils, drain pans, fans, and controls. Instead of testing, a visual inspection (walk-through) can identify many likely sources and pathways, which are often inexpensive to fix.

Indoor environments can be significantly impacted by climate changes such as large increases or decreases in rainfall and snowfall, extremely high or low temperatures, and changes in the severity of storms. Increased rainfall may lead to increased risk of flooding and dampness indoors, and growth of mold indoors. Decreased rainfall or droughts may lead to wildfires that will create particulate air pollution that can seep indoors. Extreme temperatures and storms may drive people to stay indoors to protect themselves from the elements, and increase their use of heating, ventilation and air condition (HVAC) systems. The speaker will discuss these findings, which suggest methods by which engineers and architects can make our buildings more climate-ready.

About the Speaker

From 1991 to April 2018, Henry Slack managed the Indoor Air Program for the U.S. Environmental Protection Agency (EPA), Region 4, which covers eight southeastern states. In this position, he offered expertise concerning indoor air to citizens or public agencies with questions on topics as diverse as mold, odors, ozone, carbon monoxide, air cleaners, ventilation systems, and secondhand tobacco smoke. The EPA program is non-regulatory.

Mr. Slack earned a Bachelor of Science in Chemistry in 1974 from Southwestern at Memphis (now called Rhodes College) in Memphis, Tennessee, and a Master of Science in 1980 from Georgia Institute of Technology. He joined ASHRAE in 1988.



Although he retired from EPA, he has been happy to continue as a Distinguished Lecturer for ASHRAE. He also volunteers with the Citizens' Climate Lobby, a nonpartisan grassroots advocacy organization focused on national policies to address climate change.
